General Information

If you have questions about this program, please do not call the Police Department. Call the Traffic School Message Line after you have read this entire brochure. If you have been court ordered to attend a defensive driving school, this class DOES NOT qualify.

In Class Overview

Kent Traffic School is a 3 ½ hour traffic safety education program for drivers who have been cited for a minor traffic infraction. It includes current driving laws, safe driving techniques, and Kent-specific traffic data to make the driver more aware and knowledgeable about local driving conditions.

After successful completion of the class, the City Prosecutor will file a motion to dismiss your violation; there will be no further fine or legal action and you will not have to appear at your court hearing.

If your citation has two or more violations, (ex. violation 1=speed; violation 2=no tabs), you are responsible for handling the additional violation(s). Kent Traffic School allows you to keep **one** from your driving record.









Online Class

Kent traffic School Online Class is a 4 hour traffic safety education program for drivers who have been cited for a minor traffic infraction, and cannot make it to the in class program. The online class is divided in to timed sections, that can be completed all at once, or over a period of a few days. This class needs to be completed 2 weeks before the court hearing date. There is a test at the end, and an 80% pass mark is required.

After successful completion of the online class, the City Prosecutor will file a motion to dismiss your violation; there will be no further fine or legal action and you will not have to appear at your court hearing. If your citation has two or more violations, (ex. violation 1=speed; violation 2=no tabs), you are responsible for handling the additional violation(s). Kent Traffic School allows you to keep ONE from your driving record.

The following conditions are NOT ELIGIBLE for Kent Traffic School:

- Currently on deferral
- This ticket violates probation
- Currently have an ignition interlock
- No insurance at time of citation
- Current violation is for speeding 21 MPH or more over posted limit
- Major traffic infractions or criminal traffic citations
- Extensive driving or criminal record
- Violation of Intermediate or Drivers License Restrictions
- Traffic violation for CDL holder
- You have attended Kent Traffic School in the last 24 months
- Failure to yield to an emergency vehicle.
- Littering from a motor vehicle.
- Negligent driving 2nd degree.
- No valid operators license with ID.

Kent Traffic School Instructions





MUNICIPAL COURT

- Within fifteen (15) days of the date you receive your ticket you must request a contested or mitigation hearing. Please check one of the hearing boxes and write "Traffic School" below your signature.
- Hand deliver or mail the green portion of your ticket to Kent Municipal Court, located at 1220 Central Ave S, Kent WA 98032—open Monday to Friday between 8:30 AM and 4:30 PM.
- Advise the court you will be applying for Kent Traffic School.
- The court will schedule a hearing; attempting to allow time for you to attend Kent Traffic School.



KENT POLICE DEPT

DO NOT delay in applying for Kent Traffic School as you must attend at least 2 weeks prior to your court date; and classes fill up quickly.

- After receipt of your court date, apply in person at the Kent Police Department, located at 232 4th Ave S, Kent WA 98032—Monday to Friday, 8 a.m. to 6 p.m., weekend hours call: 253-856-5800
- You must have the following to apply:
 - 1. Court hearing notice
 - 2. Driver's license
 - 3. Completed application

Or you can apply on-line at: **kentwa.gov/police/ programs/traffic/trafficschool**. On-line application must also include a copy of your driver's license and a copy of your court date or the application will not be processed.

- You will be notified by mail (in about 10 working days) regarding your acceptance to Kent Traffic School and your class date and time.
- If ACCEPTED, proceed to Step 3.

If **DENIED** to Kent Traffic School, you will receive a letter indicating why you are ineligible. YOU MUST THEN APPEAR AT KENT MUNICIPAL COURT ON THE HEARING DATE YOU RECEIVED OR OTHERWISE PROPERLY HANDLE YOUR INFRACTION. Failure to comply with the court order could result in loss of your driver's license.



KENT TRAFFIC SCHOOL - In Class

- A non-refundable \$100 class fee must be received prior to your class date.
- You must attend the entire 3 ½ hour class assigned to you. There are no refunds or rescheduling of classes.
- You must be in class at the start of class time, be alcohol and drug free, behave appropriately, and keep your cell phone/pager turned off.

KENT TRAFFIC SCHOOL – Online Class

- A non-refundable \$136 class fee must be paid before you can go online and complete the class.
- You must have access to a computer and Wi-Fi to do this class.
- You must complete the entire online class and pass the test. There are no refunds.
- The online class must be completed at least 10 business days before your court hearing date.
