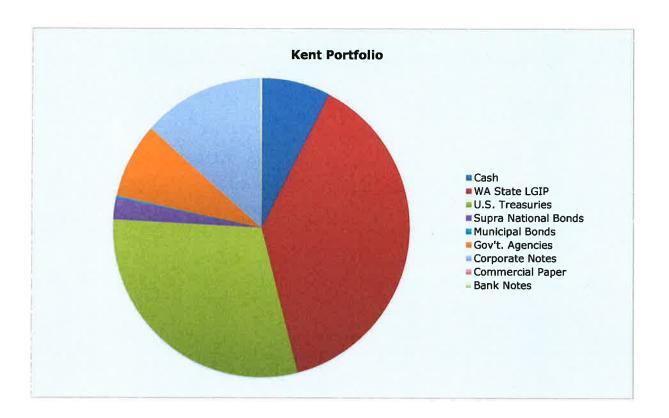

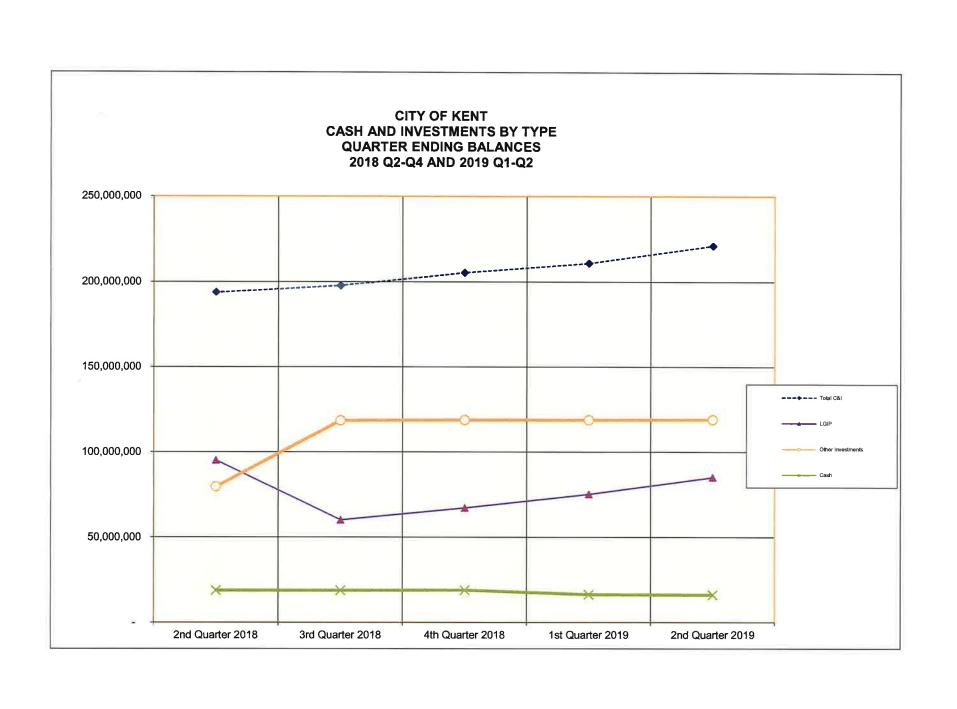

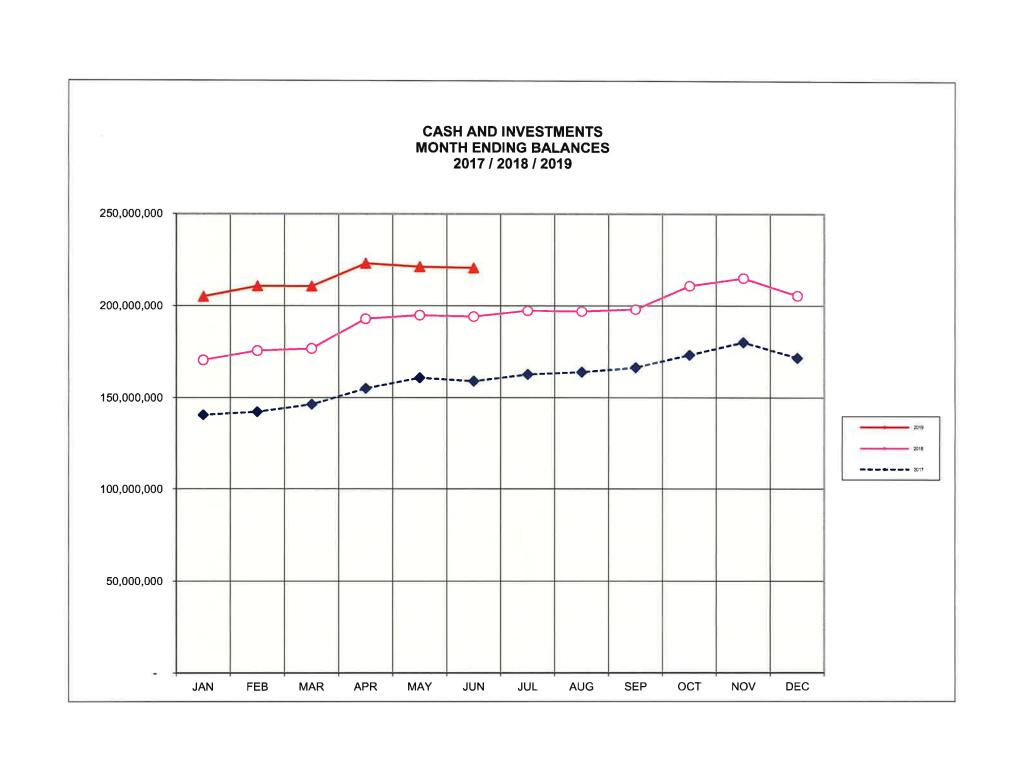
The City is currently carrying greater than adequate liquidity in cash and the LGIP.

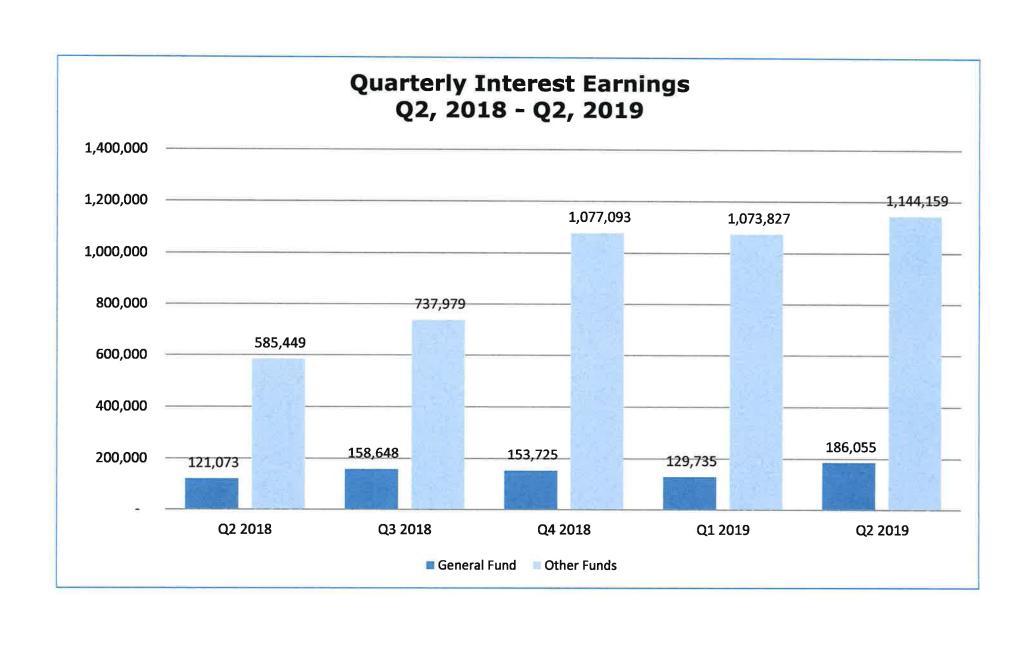
Portfolio allocations at 06/30/2019 were in compliance with the City's investment policy.

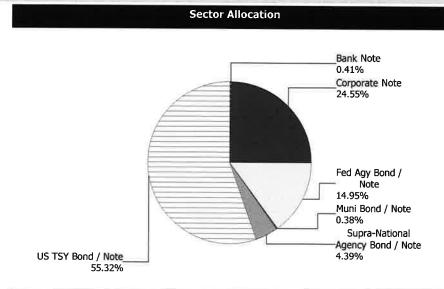
