**NOTICE OF FIRST PUBLIC HEARING REGARDING THE DEVELOPMENT OF  
THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG)  
2023 ANNUAL ACTION PLAN**

In accordance with 24 CFR 91.105, notice is hereby given that the City of Kent will hold its first public hearing on September 6, 2022 to receive comments from Kent residents, low/moderate-income persons, non-governmental organizations (AKA nonprofits), and other interested parties regarding the development of the City's CDBG 2023 Annual Action Plan for Housing and Community Development. Comments will be received by the Kent Human Services Commission and/or CDBG Program staff.

The 2023 Annual Action Plan outlines the City's proposed use of 2023 Community Development Block Grant (CDBG) funds awarded to the City by the U.S. Department of Housing and Urban development (HUD) under Title 1 of the Housing and Community Development Act of 1974 as amended, known as the Community Development Block Grant (CDBG) Program. The Plan also identifies the objectives and strategies that will guide the City's investments. The City's Program Year for investing these funds runs from January 1, 2023 to December 31, 2023. In PY 2022, the City received \$1,159,798 in CDBG funds and estimates that it will receive the same amount or less in 2023.

**COMMUNITY PARTICIPATION PROCESS**

All interested persons are invited to attend a public hearing to provide comments and recommendations to the City on how CDBG funds should be invested in 2023. This is an opportunity for residents, stakeholders, non-profit organizations and others to influence the Annual Action Plan before the initial written draft is completed.
